More than half of the human population lives and works in rural areas, mainly engaged in agricultural activities. This ancient human activity produces food and uses land. In a world where the demand for food is quickly growing, the quality and quantity produced by agriculture may ensure the health of billions people. However, modern agriculture is also capable of causing resource depletion and environmental pollution. Despite major social, cultural, ecological and demographic relevance, rural areas are largely neglected by research and social protection. Rural inhabitants are suffering from an evident gap in quality of life, sanitation, income, and distribution of social protection and economic benefits, including occupational health protection and service. The International Congress on Rural Health calls all international experts in rural health, along the lines already

defined by the World Health Organization in the "Health for All" program. The main objectives are to reinforce Primary Health Care and Occupational Health services in the rural sector as the way to achieve universal health service coverage, and to integrate Occupational Health services within Primary Health Care. All main stakeholders involved in rural health will be present, and with them the main international organizations active in the sector. The venue for the Congress will be Brescia, a historical town located in the Region of Lombardy. Brescia is characterized by a strong agricultural vocation and has a unique richness of enterprise. Boasting a unique and marvelous landscape, several monuments, and a natural hospitality, Brescia is an ideal host city for the Congress. Moreover, Milan, center of the Lombardy Region, will host the 2015 Universal

Exhibition "Energy for Life, Feeding the Planet", during which rural agriculture will be strongly highlighted. Participation in this event will be a unique opportunity to visit EXPO 2015 and participate in the global debate on agriculture in rural areas. Importantly, rural communities are organized in villages, where agriculture and related activities are carried out very often by entire families, in which women, children and elderly represent an important demographic.

Background

The village is the target of all preventive interventions in rural areas. Only a healthy village, inhabited by healthy dwellers, can produce healthy food for the entire community and respect for the living environment.



At the end of the 16th International Congress on Rural Health, held in Lodi (Italy) in June 2006, the "Lodi Declaration on Healthy Villages" was approved, and the Global Movement on Healthy Villages was launched.


The Lodi Declaration highlights that due to the complexity and specificity of rural areas, the approach to rural health needs to be holistic, crosscutting, and integrative. Cross cutting needs include different levels of expertise, (involving for example academia, rural health practitioners, rural community leaders); amongst disciplines (involving general medical practitioners, occupational and environmental me-

dicine, agronomic sciences, veterinary medicine, rural sociology, and health systems); and among countries, particularly addressing rural differences between the industrialized world, growing developing countries and countries in transition. This was partially achieved by the Cartagena Declaration issued duting the 17th International Congress in Agricultural Medicine and Rural Health in October 2009, by means of which the region of Latin America committed to strengthening Rural Health and Medicine in this developing region. However, the following specific objectives remain to be achieved:

• Promoting and enforcing universal coverage and access for disadvantaged populations to Primary Health Care and Occupational Health Care, to improve the health status of rural workers and dwellers and to reduce social inequalities;

- Improving the overall quality of rural enterprises, to produce adequate amounts of high quality food, taking into account both nutritional, safety and hygienic issues;
- Reducing the environmental impact of agricultural activities all over in the world, through the diffusion of "green economy" principles and climate change mitigation and adaptation;
- Reducing the burden of disease attributable to occupational and environmental risks in the workplace, to environmental pollutants generated by agricultural activities, and to the consumption of unhealthy diet.

The proposal


